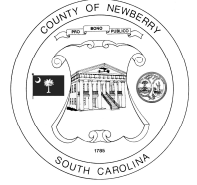

The Newberry County Registration and Election Board met on Monday, January 8<sup>th</sup>, 2023, at 1:00 pm at the election office.

Chairman John Glasgow called the meeting to order, and Sam Price gave the invocation.

Board Members present were Chairman John Glasgow, Vice-Chairman Brenda Fulmer, Doretha Simpson, Henry Summer, Tony White, Secretary Sam Price, and Martha Waller. Deputy Director Sheli Madray was also in attendance.

The quorum was established by Chairman John Glasgow.

Tony White made the motion to approve the agenda for the January 8<sup>th</sup>, 2023, Board meeting. Henry Summer seconded, and the agenda was approved as written.

Martha Waller made the motion to approve the minutes from the December 11<sup>th</sup>, 2023, Board meeting. Brenda Fulmer seconded, and the minutes were approved as written.
