The Newberry County Registration and Elections Board held its regular monthly board meeting Monday, May 6, 2024, at 1:00 p.m. at the election office. Chairman Tony White called the meeting to order.

Commissioners present were Chairman Tony White, Brenda Fulmer, John Glasgow, Sam Price, Henry Summer, Doretha Simpson and Martha Waller. Also present was Interim Director Sheli Madray.

The invocation was given by Sam Price.

A quorum was established with all 7 board members present.

Doretha Simpson made the motion to approve the agenda. John Glasgow seconded. The motion was approved.

Doretha Simpson made the motion to approve the minutes of the April 1, 2024, board meeting, the April 9, 2024, called board meeting, the April 11, 2024 election certification meeting, the April 11, 2024 called board meeting and the April 22, 2024 called board meeting. Henry Summer seconded. The motion was approved.

Under old business, there will be an additional Municipal election on June 11, 2024, for the two town council seats and the mayor for the town of Peak.

The board interviewed applicants for the vacant position of Newberry County elections director before and after the regular board meeting today.

UOCAVA ballots were completed on Friday, April 26, 2024.

Under new business, Interim Director Madray has obtained bids from 3 moving companies and has chosen Gentlemen Movers, LLC to handle the delivery and pick-up of the election equipment to the polling precinct locations at a much lower cost than previously charged. John Glasgow made the motion that Gentlemen Movers, LLC be used for the delivery and pick-up of the election equipment. Brenda Fulmer seconded. The motion was approved.

The deadline to register to vote in person for the June 11, 2024, Democratic and Republican Primaries is Friday, May 10, 2024. The on-line registration deadline to register is Sunday, May 12, 2024. The postmarked mail registration deadline is Monday, May 13, 2024.

Poll worker training will be held Tuesday, May 14, 2024, at 9:00 a.m.; Wednesday, May 15, 2024, at 12:00 p.m.; Thursday, May 16, 2024, at 3:00 p.m.; Tuesday, May 21, 2024 at 9:00 a.m., Wednesday, May 22, 2024 at 12:00 p.m.; and Thursday, May 23, 2024 at 3:00 p.m. at Piedmont Technical College in Newberry. Poll workers are being contacted by phone, email and letter regarding working the election and of the training schedule.

Early voting for the primaries runs Tuesday, May 28, 2024, through Friday, June 7, 2024, Monday through Friday from 8:30 a.m.-5:00 p.m. at the election office.

The Absentee ballot application deadline for the June 11, 2024, primary elections is Friday, May 31, 2024.

The statewide Democratic and Republican Primary Election is Tuesday, June 11, 2024, from 7:00 a.m. to 7:00 p.m.

Following information from Interim Director Madray, Chairman White made the motion for the office to decide how many emergency ballots and possible run-off ballots for the US House of Representatives District 3 seat are needed at an approximate cost of \$800.00 and to move funds in the budget to cover this cost. John Glasgow seconded. The motion was approved.

There being no further business, Brenda Fulmer made the motion to adjourn. Martha Waller seconded. The motion was approved. The meeting was adjourned at 1:45 p.m.
