The Newberry County Registration and Elections Board held its regular November monthly board meeting Monday, October 28, 2024, at 1:00 p.m. at the election office at the request of the election office staff. Chairman Tony White called the meeting to order. The invocation was given by John Glasgow.

Board members present were Chairman Tony White, Brenda Fulmer, John Glasgow, Doretha Simpson and Martha Waller. Also present were Director Sheli Madray and Area Representative Tiffany Smith. Board member Sam Price was absent. Board member Henry Summer was absent but excused.

A quorum was established with 5 board members present.

John Glasgow made the motion to approve the agenda. Brenda Fulmer seconded. The motion was approved.

Doretha Simpson made the motion to approve the minutes of the October 7, 2024, board meeting. John Glasgow seconded. The motion was approved.

Under old business, Director Madray stated that poll worker training has been completed through 2 in-person clerk training sessions and 4 in-person poll worker training sessions. Those unable to attend an in-person class have completed an on-line class available through the State Election Commission.

Early voting which began Monday, October 21, 2024, has seen over 5,200 voters cast their ballot as of noon Monday, October 28, 2024, in Newberry County. Early voting continues through Saturday, November 2, 2024, at 6:00 pm.

Under new business, the election office will begin removing the absentee ballots mailing secrecy envelopes on Monday, November 4, 2024, at 10:00 am. Over 600 absentee ballots have been received from Newberry County voters as of Monday, October 28, 2024.

Election equipment will be delivered to the various polling precinct locations on Sunday, November 3, 2024, and Monday, November 4, 2024, and will be picked back up on Wednesday, November 6, 2024. Polling precinct clerks will pick up their materials on Monday, November 4, 2024, at the election office. Election day is Tuesday, November 5, 2024, with all precincts open from 7:00 am until 7:00 pm and fully staffed. Hand count audits will be conducted on Wednesday, November 6. 2024 at 9:00 am with election canvass and certification on Thursday, November 7, 2024, at 10:00 am.

There being no further business, Martha Waller made the motion to adjourn. Doretha Simpson seconded. The meeting adjourned at 1:40 pm. The next scheduled board meeting is Monday, December 9, 2024, at 1:00 pm.
