Commissioners present were Chairman Tony White, Brenda Fulmer, Sam Price, Doretha Simpson, Henry Summer and Martha Waller. Commissioner John Glasgow was absent. Also present were Interim Director Sheli Madray and Kelly Duncan from the Newberry Observer.

A quorum was established with six board members present.

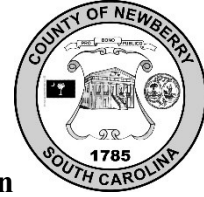
Martha Waller made the motion that the board convene as the county board of canvassers for the certification of the Peak Special Election for Mayor and Town Council and the Democratic and Republican Primaries held Tuesday, June 11, 2024. Henry Summer seconded. The motion was approved.

Interim Director Sheli Madray administered the constitutional oath to the board members. Commissioners then signed the State of South Carolina, Newberry County Board of Canvassers Members Oath form.

On Wednesday, June 12, 2024, at 9:00 am a hand count audit was conducted for the precincts of Newberry Ward 5, Consolidated #5, Prosperity Outside and the first day of early voting. Conducting the hand count audit was Interim Director Sheli Madray. Performing the hand count audit were Doretha Simpson, Martha Waller, Tony White, Christianna Gilliam, Roy McClurkin and Lisa Toland.
