**September 9<sup>th</sup>, 2024**

The Newberry County Registration and Elections Board held its regular monthly board meeting Monday, September 9, 2024, at 1:00 p.m. at the election office. Chairman Tony White called the meeting to order. The invocation was given by John Glasgow.

Commissioners present were Chairman Tony White, Brenda Fulmer, John Glasgow, Sam Price, Doretha Simpson and Martha Waller. Also present were Director Sheli Madray and Deputy Director Danial Piester. Commissioner Henry Summer was absent due to illness.

A quorum was established with 6 board members present.

John Glasgow made the motion to approve the agenda. Martha Waller seconded. The motion was approved.

Doretha Simpson made the motion to approve the minutes of the August 5, 2024, board meeting. John Glasgow seconded. The motion was approved.

Under old business, Director Madray informed the board that Ballot Marking Devices and Electronic Poll Books maintenance and updates were completed by the end of August. Asset Management is complete except for the USBs and the new DS300s scanners which will arrive Thursday, September 12, 2024. This is an equipment upgrade replacing the current DS 200s scanners.

Under new business, Director Madray had a list of the 4<sup>th</sup> quarter training classes if anyone was interested in taking one of the available classes.

Director Madray and Deputy Director Piester will be attending the 2024 General Election Workshop for Staff and Directors on September 19, 2024, at the Columbia Convention Center. This is an all-day class, but the election office will be open.

There is an all-day Board Member Workshop on September 26, 2024, at the Columbia Convention Center for those board members who would like to attend.

Director Madray said that the ballots for the November 5, 2024, election were approved today and the data base for the election will be available September 21, 2024.

Poll Manager Training classes will be held at Piedmont Technical College Tuesday, October 8, 2024, from 1:00 - 4:00 pm; Thursday, October 10, 2024 from 3:00 – 6:00 pm; Tuesday, October 15, 2024 from 1:00 – 4:00 pm; and Thursday, October 17, 2024 from 3:00 – 6:00 pm.

Clerk Training classes will be held at Piedmont Technical College Wednesday, October 9, 2024, from 12:00 – 3:00 pm and Wednesday, October 16, 2024 from 12:00 – 3:00 pm.

Early voting for the 2024 November 5 General Election begins at the Newberry County Voter Registration and Elections office Monday, October 21, 2024. The office will be open Monday – Saturday from 8:30 am to 6:00 pm until November 2, 2024. The office will be closed on Sunday, October 27, 2024.

There being no further business, Sam Price made the motion to adjourn. Martha Waller seconded. The meeting adjourned at 1:43 pm. The next scheduled board meeting is Monday, October 7, 2024, at 1:00 pm.
